Dear Friends

We humbly thank all of you for your generous support to NICE for the past 10 years. We have been able to completely provide for quality education, boarding and lodging to 145 boys and 27 girls this year in a caring environment. A separate campus has come up for the girls and we have also constructed a staff quarters to accommodate 22 staff (teaching and non-teaching) members. This has been possible only because of sustained support from donors like you, who have seen the development of the organization and are helping us grow.

The school has continued achieving 100% pass rates in the 10th standard. Several of these students are continuing to stay with us as they pursue their 11th, 12th standard and higher studies. Two of the students were selected in Sri Satya Sai University, Bangalore for B.Sc. (Hons) degree. Another student got selected in CA (CPT) examination with good marks. All other students have also joined graduate schools and universities. Two of the children who are doing their Intermediate (10+2) are toppers in their college in Narsaraopet, Guntur. We are also supporting those who wanted to pursue jobs based on life skills and encouraging them to join in ITI courses from other institutions.

Financial support from donors has increased from Rs 2 lakhs (during 2002-03) to Rs 75.3 lakhs (during the 2011-12 financial year). To date, for the past 10 years, I have been running the organization without taking a single rupee as salary. A lot of people have come forward to extend support to my family, and for our children's education. I am grateful for the voluntary contributions of many people: Giri Kolanupaka (website of NICE), K. Jeevan Babu and G. Sambasiva Rao (for finalizing the accounts within one week of the financial year end), Sharath Chandra (Butterfly Fields) for providing training in Maths and Sciences without expecting anything in return, Seetha Murthy and Dhanunjaya (Director of Silver Oaks School, supporting our children's education) to name a few. I specially thank Mr. Abhilash Nama (USA) and M. Satish (UK) and their families who have been helping me meet my personal expenses. Because of them and all other volunteers who are supporting the work of NICE in numerous other ways, our organization's administrative expenses are extremely low (less than 3%). We are also not taking any funding from the Govt of India or the State Govt. We place on record our deep appreciation and special thanks to Microsoft, Asha, NetEnrich Technologies, SVS Projects, Intelligroup Asia Pvt.
